
# The use of Excel


#### Our tools benefit of the advantages of Excel:

- Who don't use or know it ? Users usually like this application
  Copy then paste : your report is filled
- If you report for many entities, make a copy of the tools for each ones then open and edit the dedicated copies for each specific entity from month to month
- You can also save a copy of the macros from month to month if you need to keep a backup of the filled table
- You can rename the macros filename to include, for instance, the reported company name

#### How to organize?

Create as many directories than entities you report for (do not forget the backup directory)





Make a copy of the tools in each directories for each entities Rename the macro to include entity's name

You can also create a sub-directory to keep an history of sent reports

Add visibility

You can edit the big top cell at the top of each tools and write the reported company's name

... or you can use the dedicated "Entíties list" function we added early 2020 which automates the process

These options can be helpful if you manage multiple entities

Copy/Paste

If your IT department can extract all the numbers in a simple text file or even an excel one, you can fill one full report with a simple copy / paste operation (\*)

This can be useful and time saving if you report for many entities.

\* For the TPT-Type reports tools, we implemented a dedicated "Paste" button

### Extra controls

We implemented all the controls and verification as required by the regulator(s), but we also added :

- ✓ Additional financial rules and inter-fields dependencies
- ✓ Supplementary capture masks and rules for many specific fields
- ✓ Dynamic and contextual fields and list box
- Auto-sum amounts for dírect verifications
- ✓ Quality filters rules (non blocking) with user's warning
- Verification of duplicate rows

More controls at the capture step will prevent to send bad or incomplete reports to the regulator and then avoid time-consuming dialogue with them, corrections, re-generation and re-sending

# Unique functions/options

The tools also benefit of the following :

Cross-check function to verify the monthly TPT numbers with the quarterly report

- ✓ Allow 2 capture methods for TPT-type reports
- ✓ List function for fiduciaries, to manage many entities (\*)
- ✓ For large screen, all the table can be displayed (TPT-Type)
- Can specify a default target directory to generate the reports
- ✓ Option to activate an extra backup directory of the reports(\*)
- ✓ Remove from 1 to X rows in 2 click
- ✓ Function to rapidly duplicate a row (TPT-type)
- ✓ Auto change the date to the next report

# About the license model

We verify with you, once a year, in January, the list of entities you report for. Based on this list we send you an invoice for the full year, and later on, a copy of the tools, under your license name, for the concerned year

If you have to report for new entities during the on-going year : - Before mid year : we'll charge any addition in a delta invoice in July - After mid year : we offer the license for the rest of the year

If you have past years reports to generate, then contact us. General rule is 50% of the license cost per years of delay.
